

# The Ultimate Bass Fishing Challenge Official Entry Form

We have read and understand the rules and enclosed the completed application and our entry fee, payable to TUBFC. In signing this application, we hereby waive, and release all other contestants, sponsors, government entities and their agents, and tournament officials from all claims from injury and/or damages incurred in connection with this tournament. We agree to maintain a minimum of \$100,000 liability insurance on any boat we use in any TUBFC tournament. We agree to submit to any testing required by the Tournament Director and abide by the Tournament Director's decision in all matters and agree there is not a right of appeal from their decision. Check or money order must accompany this form to qualify for tournament entry. **Entry forms for each tournament that are not completed in full and signed by both parties will not be accepted. NO EXCEPTIONS.**

## Membership Fee is \$25.00 per year, per angler.

Membership is optional for a maximum of two tournaments, but non-member teams will not acquire Divisional Points, qualify for the Classic, or participate in any membership-only drawings for prizes. Membership must be paid before a tournament not after for the tournament to count toward membership participation.

The Entry Fee is \$100.00 + \$10.00 big bass pot + \$10 Classic Fund = \$120.00

You may deposit \$20 deposit per tournament to reserve your boat number.

5 tournament reservation \$20 x 5 = \$100 = \$100 to reserve your season, \$100 due at each tournament.

Reservation/Entry fee money will not be refunded unless tournament is officially cancelled, Reservation/Entry fee money will be transferred forward in the event of a reschedule. In the event a team cannot make a pre-entered event, the team may move the Reservation/Entry fee money to any other divisional tournament as long as the team contacts the tournament director a minimum of 3 days prior to the event. In the event a team does not check in the morning of the event they have pre-entered, their reservation money will be forfeited.
